Highlights from the October 2016 Action Meeting

Presentations

CHPS Directory of Security, Mr. Tony Saporito, presented the annual Violence, Vandalism, Weapons and Substance Abuse Report. The report is posted on the District web site, www.chclc.org, under the “Departments” pull-down menu at the “Security” link.

Board Representative Reports

Cherry Hill High School East Representative Kaitlyn Boyle noted that the Lab Theatre production of *Get Bill Shakespeare off the Stage* was a success. She mentioned that the East Marching Band received a rating of “Outstanding” on October 15 at the William Tennent Celebration of Bands. The group competed against eight bands from various Pennsylvania schools. Ms. Boyle said the first issue of Eastside newspaper came out earlier in the day – highlights include a feature on Principal Dr. Dennis Perry and Women in Engineering. She noted that the first Robotics competition would be held Saturday, October 22. She also said East’s Fall Preview Concert would take place October 25 at 7:30 pm. Ms. Boyle mentioned student concerns regarding Biology classes at East, as well as students’ desire for a shorter PARCC schedule that does not impede AP test preparation. She noted the first football game on the new turf field and the fact the East Girls’ Volleyball are currently division champs. She also shared the “breaking news” that East Girls’ Tennis won the Group 4 Championships.

Cherry Hill High School West Alternate Student Representative Abby Spencer noted that the West Fall Show, *The Odd Couple (Female Version)* would be opening October 20 and running through October 22. She said rehearsals for the West Children’s Show, *School of Rock*, were underway for what promises to be a “fantastic” show. Ms. Spencer mentioned that West Girls’ Soccer goalie, senior Abby Everhardt, achieved her 100th save for the season, and senior Robert Abrams

won his first Camden County Cross Country Championship. In West music, she said, preparations are underway for the combined Winter Concert. She added that students were looking forward to Friday’s football game against Winslow Township, as the Lions are hoping to maintain their undefeated record. She also mentioned that the Roar Store at West would open the week of October 24 to sell West merchandise. Ms. Spencer wrapped up her presentation by noting that the theme for Spirit Week in November would be “Disney.”
