The number of students allowed to be transported in a private vehicle to and from a related school activity shall not exceed one less than the maximum recommended for the vehicle.

Names of Students to be Transported	
	Regardless of vehicle capacity, no more than 7 students may be transported in a privately owned vehicle.

Driver Statement of Assurances	
The initials of the driver indicate that the following items have been read and are understood.	
Requirements	Initials of Driver
The driver has a valid New Jersey driver’s license with no convictions for moving violations no guilty pleas or pleas of no contest for moving violations within the last three (3) years.	
Automobile liability insurance for bodily injury and property damage of at least \$1,000,000 combined single limit per occurrence pursuant to N.J.A.C.6A:27-1.7(a), which is obtained through a company authorized to issue insurance in New Jersey.	
The certificate of insurance shall name the Cherry Hill Public School District Board of Education as an additional insured party to the policy pursuant to N.J.A.C.6A:27-1.7(a).	
The driver agrees to immediately report student misconduct to the staff member supervising the activity, who will be responsible for reporting this to the Principal or the Principal’s designee.	
The driver agrees that upon arrival at the destination, to deliver students to the staff member in charge, who will be responsible for the students at the activity.	
The driver agrees that upon conclusion of the activity, s/he will return students to the school and deliver students to the staff member in charge, who will be responsible for the students until they are picked up by a parent/guardian.	
The vehicle must be a private passenger vehicle, owned or leased by the driver or his/her spouse.	
The capacity of the vehicle is eight (8) or fewer passengers.	
The vehicle meets all of the safety requirements of the State of New Jersey Motor Vehicle Commission, including but not limited to one seat belt for each occupant of the vehicle.	
There is a valid motor vehicle inspection sticker on the vehicle.	
The vehicle’s registration is current.	
The driver will not transport any student(s) whose parent has not given consent.
