### **Welcome to Cherry Hill Public Schools!**

You have the option to complete the registration process electronically or to schedule an appointment to complete the process in person. To schedule an appointment, please call (856) 429-5600 x4429.

#### Information for registering new students to our district are as follows:

#### 1. Pre-Registration:

Go to <a href="www.chclc.org">www.chclc.org</a>, to pre-register your child(ren) online. Click on 'Departments' and then 'Registration'. All information about the registration process can be found on that page. When you are ready to pre-register your child(ren), click 'Begin the Genesis Pre-Registration Process'. If you plan to complete the registration process electronically, all required documents must be uploaded at this time. All additional forms are included in this packet.

#### 2. Required Documentation for Registration:

- 1. Parent Photo ID (*Photo ID issued by a government, public body, or authority.*)
- 2. Two Parent Proofs of Residency (*Please see below*.)
- 3. Child's Birth Certificate or Passport
- 4. Most Recent Immunization Records
- 5. Evidence of a recent Physical Examination (Must be submitted within 30 days of registration.)
- 6. Most Recent Report Card or Transfer Card (If applicable.)
- 7. District Registration Packet (Attached.)
  - o Proof of Domicile
  - Request for Student Records
  - o Physical Exam Mandate
- 8. IEP or 504 Plan (*If applicable*.)
- 9. Custody Documentation (*If applicable*.)
- 10. Proof of a Negative Tuberculosis (TB) Test (If applicable.)

#### **Parent Proofs of Residency:**

In accordance with New Jersey Administrative Code 6A:22-3.4 **Proof of eligibility**: A district board of education representative shall accept the following forms of current documentation or similar forms of documentation from persons attempting to demonstrate a student's eligibility for enrollment in the Cherry Hill School District. **ALL documents must contain the parent's name, Cherry Hill address, and be dated within the past two months.** 

- If you own your home, please submit TWO documents, such as: property tax bill, mortgage statement, current utility bills, financial account information, employment documentation, or any other business record or document issued by a government entity.
- If you recently purchased your home, please submit a copy of your Deed (1st page and signature page only), AND a copy of your Closing Disclosure (1st page and signature page only) OR a copy of your homeowner's insurance.
- **If you rent**, please submit a copy of your current signed lease, AND a current utility bill, financial account information, employment documentation, or any other business record or document issued by a state or local government entity.
- If you live with someone who owns a house in Cherry Hill, please download and complete the <u>Landlord</u>

  <u>Affidavit</u>. Both the owner and tenant must submit two proofs of residency and sign the Landlord Affidavit in the presence of a Notary.

The totality of information and documentation you offer will be considered in evaluating an application, and, unless expressly required by law, the student will not be denied enrollment based on your inability to provide certain form(s) of documentation where other acceptable evidence is presented.

You will *not* be asked for any information or document protected from disclosure by law, or pertaining to criteria which are not legitimate bases for determining eligibility to attend school. You may *voluntarily* disclose any document or information you believe will help establish that the student meets the requirements of law for entitlement to attend school in the district, but *we may not, directly or indirectly, require or request*:

- Income tax returns
- Documentation/information relating to citizenship or immigration/visa status, unless the student holds or is applying for an F-1 visa
- Documentation/information relating to compliance with local housing ordinances or conditions of tenancy
- Social security numbers

Please be aware that any initial determination of the student's eligibility to attend school in this District is subject to more thorough review and subsequent re-evaluation, and that tuition may be assessed in the event that an initially admitted student is later found ineligible. If your student is found ineligible, now or later, you will be provided the reasons for our decision and instructions on how to appeal.

\*Middle School and High School Scheduling Information: After the registration is finalized, the school's Guidance Department will contact you directly to arrange a scheduling appointment.
