Landlord Affidavit Instructions

If you live with someone who OWNS property in Cherry Hill, this is what you need to complete in order to have your child registered in the Cherry Hill Public Schools system. It is required that you complete this form **and bring it with you** to your appointment with the Registration Office. It must be **signed and notarized**.

You must also provide us with the following **CURRENT INFORMATION**:

- **2 Proofs of Residency for Cherry Hill from the OWNER of the property**: *Property Tax Bill, Mortgage Statement, Current Utility Bills (i.e., PSE&G, Water, Sewer, Telephone, Cell Phone – NO CREDIT CARD BILLS), Financial Account Information, Employment Documentation, or any other business record or documentation issued by a government entity. They must be dated within the two months prior to your registration appointment.

**** PLUS:**

- **2 Proofs of Residency for Cherry Hill from the TENANT**: *Current Utility Bills (i.e., PSE&G, Water, Sewer, Telephone, Cell Phone – NO CREDIT CARD BILLS), Financial Account Information, Employment Documentation, or any other business record or documentation issued by a government entity. They must be dated within the two months prior to your registration appointment.
