### Highlights from the August 27, 2019 Action Meeting

#### **Board Representative Reports**

Cherry Hill High School West Alternate Representative Jack Begley reported that several fall sports teams had been having scrimmages in past few weeks, with excitement for the upcoming season. He noted that the West Peer Leaders recently went on a retreat to Camp Ockanikon, which he attended. He added that in addition to having a lot of fun, participants learned teambuilding and leadership skills. Mr. Begley said that Freshman Orientation had been happening at the school for the past two days and would continue on Wednesday, August 28.

Cherry Hill High School East Representative Jacob Graff reported that fall sports practices continue at East, and that some practices had to be canceled earlier in the summer because of heat. He noted that the auditorium construction was progressing, with a projected finish date at the end of the 2019-2020 school year. East's plays and musicals, he added, will be performed at West, and transportation to dress rehearsals will be covered. Mr. Graff said Freshman Orientation would be tonight at East, and that Dr. Perry was very excited about it. He noted that this would be the first year for Chinese 2 in the language program at East, and that there would be three Level 1 classes and three Level 2 classes offered. He added that security vestibule construction is set to begin and continue through the school year. Entrance and exit to and from the school will not be affected, he noted. Mr. Graff went over a list of new hires on staff at East. He said Dr. Perry would be leaving all bathrooms in the school open during the school day, and all students would be required to "turnstyle" sign in and out when leaving a class to use the bathroom. Mr. Graff explained the new use of Google Classroom by parents. He also detailed new, consistent grading and graduation requirement procedures.
