Members of the Cherry Hill High School West theater department performed a preview of their upcoming spring musical, *Sister Act*.

Board Representative Reports

Cherry Hill High School West Representative Molly Burch reported on the opening of the spring sports season and upcoming fundraisers. She mentioned the upcoming National Honor Society car wash ticket fundraiser and the group's garden beautification project in the West courtyard. Ms. Burch also spoke about the Spanish AP classes sale of Pulsera bracelets to support artists in Central America.
