Highlights from the February 2016 Action Meeting

Presentations

Ms. Cathleen Jenkins of the Cherry Hill African American Civic Association, presented awards to the winners of the CHAACA Essay/Poster/Video Contest, which asked entrants to create their projects based on an African American athlete, coach, manager or other person in sports and the contribution the individual made before, during or after their involvement in a sport. Winners were recognized at all grade levels, K-12.

Board Representative Reports

Cherry Hill High School West student representative Tim Intelisano recounted what he described as one of his “favorite moments” in his high school career after West’s win of East vs. West boys basketball game. West Deca also sent more than 90 students to the DECA state conference, a school record. Mr. Intelisano noted that 17 students qualified as finalists and three leaders will be sent to the upcoming Leadership Conference in Nashville, TN. He added that for the first time, DECA is allowing special ed students to advance to the National level. West will be sending a special ed student this year, who received a standing ovation from the student body. Mr. Intelisano thanked all of administrators and Board members who stopped by the conference. He also talked about the Mock Trial Team would be competing in the South Jersey Regional Competition on February 24. Mr. Intelisano noted that this year’s Valentine’s Day Flower Sale was run for the first time by the Latinos at West Club, with great success. Mr. Intelisano reported on the recent Town Hall Meeting at West with Dr. Meloche and thanked Dr. Meloche for his work. He also spoke about the West Open House, the spring musical, *The Little Mermaid* and Broadway Night. Mr. Intelisano wrapped up by noting that the Rock Your Socks campaign had been a great success.

Cherry Hill High School East Student Representative began his report by noting how happy his fellow students are that the teacher negotiations are settled. He also mentioned the success of East’s Open House for freshmen. Mr. Meklinsky

He mentioned the senior trip coming up in beginning of March, and closed his remarks with a synopsis of the Town Hall Meeting at East with Dr. Meloche.

The Board approved the financial reports for November 2015, including the Board Secretary's Certification and Treasurer's Report, the Line Item Transfer Report, the Food Service Operating Statement, and the SACC Financial Report. The Board approved the disbursement of funds in the amount of \$9,335,109.53, as well as the bill list dated February 23, 2016 in the amount of \$ 4,093,146.44 as submitted.

The Board approved the award of vendors through state contract to Govdeals Inc. auctioneering services to sell surplus property, and to Griffith Electric Supply Co. for electrical supplies and equipment.

The Board approved a resolution authorizing the use of contracts with approved Middlesex Regional Educational Services Commission (MRESC).

The Board approved a resolution authorizing Cherry Hill to participate in New Jersey Digital Readiness Learning & Assessment Broadband Component, Wide-Area Network & Internet Cooperative Purchasing initiative (DRLAP) through Middlesex Regional Educational Services Commission (MRESC).

The Board approved an award of transportation to Hillman's Bus Service, Inc. to transport one McKinney-Vento student residing in Lindenwold, NJ to/from Kingston Elementary School.

The Board approved an award of transportation to West Berlin Bus Service, Inc., to transport one classified student residing in Sicklerville, NJ to/from Bankbridge High School.

The Board approved an award of transportation to Hillman's Bus Service, Inc. to transport on McKinney-Vento student residing in Marlton, NJ to/from Cherry Hill High School East.

The Board approved an award of transportation to First Student, Inc. to transport 7 classified students on a shuttle, from New Hope Academy in Yardley, PA, to home.

The Board approved an award of transportation to Hillman's Bus Service, Inc. to transport one classified student on a shuttle with an aide from Henry C. Beck Middle School to home.

The Board approved a change order to reduce the unexpended allowance from the Harte Elementary School Roof Replacement (deduct) \$25,000 to be issued to D. A. Nolt, Inc., Berlin, NJ.

The Board approved a resolution authorizing professional service agreements with TTI, Inc. for the provision of environmental services at Carusi Middle School and Malberg Alternative High School.
